Faith Forums

...from LSH's very own 'Sttg'

There has been some debate as to whether we should be represented on the various Faith Forums that operate in Lancashire. Generally it is felt that we would simply be outvoted and that it could also be said that we were involved in any 'consensus' that might emerge ... However, we decide to find out more about Faith Forums.

A member of LSH has attended meetings of Lancashire Forum of Faiths and Preston Faith Forum as well as looking into their accounts and their activities and objectives.

Preston Faith Forum was founded in 2002, has members from the Christian, Bahá'í, Buddhist, Hindu, Islamic, Jewish and Sikh communities and has the following objectives:

To support the Preston Strategic Partnership in the development and delivery of a Common Strategy for Preston.

To work with and in other partnerships operating in Preston.

To influence public sector decision-makers.

To exercise Forum's consultation rights.

To share concerns between faith groups.

To increase the understanding of faiths and the positive role that they and their communities can play in society.

It is only open to members of the nine faith groups recognised by the inter faith network and so it seems we could not be represented even if we wanted to be.

The meeting we attended was focussed on the plans for the 2012 Preston Guild and it was easy to see that the Forum performs a useful function in coordinating faith organisation activities.

We obtained copies of their accounts and they are turning over about £10,000pa.

The Lancashire Forum of Faiths held an open meeting on 22nd of March with a panel discussion on 'The Role of Inter Faith in a Peaceful Coexistence'.

Their 'vision' is:

The Lancashire Forum of Faiths is the voice of the faith communities and interfaith groups in Lancashire, promoting shared values and good relations, and offering advice and guidance to all sectors of society at local, regional and national level.

They state their objectives as:

Provide advice to public bodies.

Work in partnership with the statutory sector to raise awareness of the work of faith and interfaith communities.

Act as a consultative forum on local faith/religious issues for local government.

Send Forum representatives to serve on local strategic initiatives.

Promote good community relations.

Hold educational events and exhibitions.

We encourage and engage in multi-faith dialogue.

Organise discussion meetings on religious topics.

Organise discussion meetings on social issues.

Raise awareness of inter-faith events, organisations and issues.

Visit places of worship.

“What if you were [say] not a Potholer ... you wouldn't concern yourself with potholing? If I wasn't a potholer I wouldn't care less about it!”

This was put to me recently and (on the face of it) my questioner has a point ... but wait!

What if the Government were to invite 26 of the highest potholing officials in the land [let's call them Fishups'] to become part of the legislature which makes the laws that govern everybody – even though they'll only vote how and when the Chief-Fishup tells them to; and in ways intended to advance the aspirations of potholers ... Despite the fact that the number of people who actually go potholing is very small indeed.

I'm not talking about people who have occasionally thought they might like to go potholing.

Or those who quite enjoy the kudos claiming to be a potholer may bring.

Or those who tried potholing a couple of times before deciding it wasn't really for them.

Or those who have been injured as a result of potholing.

No! ... I'm just talking about those people who make the effort to get out of bed in the morning, put on their potholing clothes, and actively participate in something they think is wonderful ... even if a great many other people think it pointless - and a bit silly.

What if that same Government offered to build lots of schools; entirely with public money, and give them to the Fishups to run, in whatever way they see fit. And the Fishups decide that, even though these schools haven't been paid for by potholers - won't be maintained by potholers - and it won't be potholers picking up the wage bill and other running costs; they are nevertheless going to keep them just for children of potholers – [provided (of course) their parents are able to demonstrate they've been potholing regularly.]

It doesn't matter that the children attending the schools aren't themselves potholers, or indeed have any desire to become potholers.

All that matters is their parents are!

Child Abuse and the Holy See

KPW relentless in pursuit of JR & RC Church

The Pope and the Vatican's record on child abuse have been challenged today [16/03/10] at the United Nations. Both were criticised with unprecedented candour at the UN Human Rights Council by Keith Porteous Wood, Executive Director of the National Secular Society.

Keith, who made the intervention in Geneva on behalf of the International Humanist and Ethical Union (IHEU), said: "Billions of dollars - and euros - have already been paid out in respect of thousands of victims in the USA and Ireland. News of further abuse has since appeared in Austria, the Netherlands and now Germany – and this is just the tip of the iceberg.

How much more evidence of children's suffering at the hands of the Church will the UN and the international community tolerate before fulfilling their responsibility to those children to hold the Vatican to account?

"The Vatican is a signatory to the UN Convention on the Rights of the Child (CRC), but has contravened several of its articles, and is more than 10 years behind in its reporting.

It has habitually compounded the abuse and facilitated multiple re-offending by moving offenders around and shielding them from prosecuting authorities by imposing the "pontifical secret".

Major investigations in the USA and Ireland have been deliberately and cynically obstructed by the Church at all levels without censure from above. This includes the Vatican's representative in Ireland, suggesting that he acted under instruction from the highest level in the Church.

All this has led to abusers being allowed to continue offending and to escape justice, while their victims despair - some even committing suicide.

"The Church cannot claim it is being victimised. It still places the protection of its reputation, and even more its assets, above the protection of those entrusted to its care. Over 90% of the compensation payments paid by cash-strapped Ireland came from the tax payers, including the abused themselves.

"When we raised this issue at the UN in September 2009, the Church blamed everyone else, but did promise a paltry *one paragraph* on clerical abuse in its report to the UN.

NON-MUSLIM SCHOOL SERVES 'STRICT HALAL' FOOD ⁴

Daisyfield Primary School in Blackburn has become the first non-Islamic school in Britain to get strict accreditation for serving halal food - it emerged at the beginning of March.

Although many UK schools already serve halal meat, they are only certified by the Halal Food Authority. Daisyfield School, on the other hand, has been accredited by the much more stringent Halal Monitoring Committee who enforce tougher checks on the packaging, delivery and preparation of food.

Although 95% of pupils attending Daisyfield are from Muslim families it is not clear how many of those families are strictly observant Muslims - neither is it clear what provisions will be made for children from non-Muslim homes.

Tory MP [David Davies] acknowledged it was important that faiths & beliefs were recognised but added a warning saying: "It is also important that we allow the full integration of immigrants. Concentration of certain ethnic groups in small areas does not help that."

LSH has written a letter to the school - the local authority - and the local newspaper ... expressing our concerns.

Even that mandatory report - already 13 years overdue and promised last September - has still not been filed with the UN.

"Following an instruction from Cardinal Ratzinger when head of the Congregation for the Doctrine of the Faith, all suspicions and accusations of child abuse were to be sent to the Vatican in secret.

Furthermore, when acceding to the Convention, the Vatican arbitrarily - and disingenuously - excluded "Vatican City state" from the jurisdiction of the Convention of the Rights of the Child (CRC).

IHEU calls on the Holy See to:

1. remove its reservation to the CRC to bring the territory of Vatican City state, to which it has instructed all abuse accusations are to be sent, under the jurisdiction of the CRC,
2. open up its files and records to CRC and state investigators, and
3. instruct all its representatives to cooperate with legal investigating authorities worldwide, something that they have signally failed to do, for example, in Ireland."

[Noel Long had been homeless and sleeping rough for 18 months and talks about his experiences with religiously motivated charitable organisations]:

Excuse me, sir, I would just like to tell you that Jesus Christ Our Lord loves you and would like to..."

I'm afraid I never found out what Jesus Christ Our Lord would like so much to do for me as, at that point, I turned on my heel and left.

The bearer of such glad tidings was a young guy who certainly didn't mean any harm, and I didn't intend to be rude. But it was eight o'clock in the morning outside Camden Town tube station and I had been fast asleep in a doorway seven seconds earlier. I was certainly in no mood for a heavy religious discussion.

At that moment in time, frankly, I was far more interested in discussing tea than theology.

Having been on the street for eight months at the time, I had noticed a lot of resentment among homeless people about the religious content of so many of the charity organisations.

Judging by some of the people I have spoken to, and many comments overheard in the queues at food drops, many regard it as, at best, patronising proselytizing and, at worst, the cynical emotional blackmail of desperate and vulnerable people ... What exactly is it that makes born-again Christians believe that they have some (literally) God-given right to try to shove their religious beliefs down everybody else's throats?

Halal School Dinners - LSH Letter

Dear Sir;

We write to express concern over the news that Daisyfield Primary School, Blackburn; is to be the first non-Islamic School in Britain to serve halal food to its pupils. As we understand it the Halal Monitoring Committee enforces strict checks on the killing, preparation, packaging and delivery of animals.

The halal method of slaughter has been strongly criticised by animal welfare organisations who claim it causes severe suffering to animals left to bleed to death without pre-stunning. The Farm Animal Welfare Council [FACW] point out that adult cattle take up to two minutes to bleed to death under halal.

Notwithstanding the Muslim Council of Britain's claim that halal provides a quick haemorrhage with no time for the animal to feel pain Judy MacArthur, Chairwoman of FAWC maintains such practices cause severe suffering saying - "*This is a major incision into the animal; to say that it doesn't suffer is quite ridiculous.*". It is for these ethical reasons that very many people choose to avoid halal meat.

What choices are offered to parents who are ethically opposed to their children being encouraged to consume meat which is inhumanely slaughtered in this way; contrary to the recommended and approved method of pre-stunning: introduced in the UK decades ago precisely because of the barbarity of cutting the throat of a conscious animal?

Cruel and inhumane practices cannot be condoned simply to placate claims that to do otherwise could cause offence to certain individuals. There is evidence that Muslim authorities and individual Muslims accept halal prepared meat from pre-stunned animals. Such practice is entirely consistent with Islamic doctrine it is simply the case that there has been no complete agreement on this question across the whole of the Muslim community.

FAWC is a prestigious, government-appointed body and their [2003] report was unequivocal that religious slaughter causes "*very significant pain and distress*". It bluntly described slaughter without pre-stunning as "*unacceptable*" and recommended that the exemption from stunning for religious slaughter should be repealed.

To defer to the views of one sector of the Muslim community in preference to a Government appointed body of experts is curious; if not perverse.

I bet (potholer or not) you'd start getting concerned about potholing then ... Just a little bit ... Wouldn't You?

They have received around £100,000 of funding in the last three years - although £80,000 was in the first 18 months.

Two of their more interesting projects involve the prevention of violent extremism and also a project whereby a team of 27 volunteers visits schools to promote faith. It's interesting that faith promotion in schools seems to be slightly outside the boundaries of their objectives. Nevertheless this was described at their meeting as their 'core work' and they are looking for funding to support paid personnel!

Given the title of their panel discussion ('The Role of InterFaith in a Peaceful Coexistence') the LSH member took the opportunity to ask how Faith Schools Contributed to InterFaith Cohesion. The panel consisted of a Quaker, a Sikh, a Druid and the Headmaster of the Preston Muslim Girls School ... The exact nature of their responses is best discussed elsewhere but three of the panel members were quite willing to present both sides of the argument.

One of the Forum members in the audience stated that discrimination on grounds of faith must obviously be illegal and was pretty shocked when the actual situation was explained to him.

In summary, it seems that Faith Forums do perform a useful purpose in promoting inter faith understanding.

This has to be a worthwhile objective - given the consequences of 'misunderstanding'.

Obviously we should be concerned that the Forums have disproportionate influence versus secular objectives.

LSH membership may not be possible or very fruitful.

However, they are a body where inter faith issues can sometimes be raised. So perhaps we should watch their activities and where possible attend specific meetings to raise issues that may help the secular cause - and indeed interfaith fairness and tolerance.

As an example we could persist on the issue of fairness in school admissions procedures.

Did - 'Does Prison Work?' - Work?

It certainly did! ... And what's more it was exactly what a Humanist meeting should be.

Zephyrine Barbarachild; a volunteer with the Independent Monitoring Board for Prisons*, addressed a well attended meeting** to give us an insight into what prisons are really like on the inside - quickly dispelling the tabloid's '*they're in five star hotels*' myth; or film & TV's insistence that prisons are little more than brutal regimes where inmates are constantly being '*banged up in the slammer*'.

And [for most of us] these are the only sources of information we're privy to about how the system works.

Zephyrine's informative and entertaining style very quickly led to a much wider discussion about the whole subject of prisons and saw humanists doing what humanists do best of all ... listening - thinking - asking - expressing - disagreeing - discovering - learning.

When any speaker goes out to address a particular group they quickly get a feel for 'where the group is coming from' and I imagine our guest was waiting to see if we were a '*prisons-too-good-for-em*' or '*Its-all-too-too- cruel*' bunch ... and I think she might have been taken aback a little by the disparate views which were aired.

Typically wide ranging in our outlooks some contributors clearly came from a concern for victims; some from a concern for offenders: still others from a more philosophical enquiry about the efficacy of imprisonment at all.

But it developed into a lively debate which (as happens all too often these days) had to be brought to a close just as it was at its most participatory ... It's certainly [another] subject we'll have to consider revisiting.
